Ordinance No. 182
AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY OF LEROY,

MINNESOTA:
WHEREAS all the owners of the premises hereinafter described have petitioned the City Council of the City of LeRoy, Mn., that said premises be annexed to the corporate limits of the City of LeRoy, Minnesota and that said premises are contiguous to and adjoining the City of LeRoy, and subject to incorporation within the corporate limits of LeRoy, Minnesota by petition to the governing body of the City of LeRoy, and WHEREAS, due notice has been given to

the Township of LeRoy, Commissioners of Mower County and the Municipal Board of the State of Minnesota, and the Township of LeRoy, Mn., effective August 14, 1979, has waived the 90 days before a city ordinance can be adopted,

NOW THEREFORE, the City Council of the City of LeRoy, Mower County, Minnesota do ordain:

Section 1. The land hereinafter

described shall be added to and incorporated within the corporate limits of the City of LeRoy, Mn., and said City Council does hereby declare said premises hereinafter described to be incorporated within and to be a part of the City of LeRoy, described as

That part of Outlot 16 in the SW¼ of Section 28-T101N-R14W, which lies south of the following described line:

Beginning at a point on the east line of said Outlot at a point 206 feet south of the center of said Section 28;

thence west 495 feet; thence south 99 feet; thence west 171 feet;

thence south 200 feet;

thence west 655 feet more or less, to the southwest corner of the LeRoy Cemetery, on the west line of said Outlot 16, and there
