AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MOORHEAD TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated the 30th day of October, 1974, requesting annexation of the territory hereinafter described was duly presented to the Council on the 16th day of November, 1974; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 5.02 acres, more or less, as platted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by the owner of the land; and

WHEREAS, no objections to the annexation have been received from the Town Board; and

WHEREAS, the land described in the petition abuts upon the city limits at the southern boundary thereof;

The Council of the City of Moorhead, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Lots One (1) through Seven (7), in Block One (1), and Lots Eight (8) through Thirteen (13), in Block Two (2) of Lillian Briggs Subdivision in the Southeast Quarter (SE½) of the Southwest Quarter (SW½) of Section Twenty (20), Township One Hundred Thirty-Nine (139), Range Forty-Eight (48), County of Clay, State of Minnesota.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
