AN ORDINANCE AMENDING ORDINANCE NO. 1.42 -- AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE

NOW THEREFORE, the City Council of the City of Pipestone, State of Minnesota, ordains as follows:


SECTION I


SECTION II
