ORDINANCE NO. 297

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES

The City Council of the City of Staples does ordain as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota by Nels H. Japke, Twylla Japke, Harold M. Giza, Esther L. Giza, Marvin Giza, and Mary L. Giza, as all of the owners of the following described real estate for the purpose of having such real estate included within the city limits of the City of Staples, Minnesota:

That part of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section 36, Township 134 North, Range 33 West described as follows: Commencing at the southwest corner of said Southeast Quarter (SE $\frac{1}{4}$ ), thence North along the west line of said Southeast Quarter (SE $\frac{1}{4}$ ) 33 feet, thence East at a right angle 33 feet, thence North and parallel with the west section line a distance of 627 feet to the point of beginning; thence East at a right angle 400 feet; thence South at a right angle 627 feet to the northerly right-of-way line of County Road No. 3; thence East along said right-of-way line a distance of 600 feet; thence North at a right angle a distance of 984 feet; thence West at a right angle a distance of 1,000 feet to the easterly right-of-way line of 8th Street; thence South along the easterly right-of-way line of 8th Street a distance of 357 feet to the point of beginning (Wadena County, Minnesota), together with all abutting streets.

Section 2. The above described real estate is unplatted, and does not exceed 200 acres, and Nels H. Japke and Twylla Japke (as contract for deed vendors), and Harold M. Giza, Esther L. Giza, Marvin Giza and Mary L. Giza (as contract for deed vendees), are the sole owners of said described property.

Section 3. Notice of the filing of the petition has been filed with the Town Board of Thomastown Township, the Wadena County Board of Commissioners, the Minnesota Municipal Commission, and the City of Staples at least 60 days prior to the first reading of this ordinance, and no objections to the petition have been received.

Section 4. All fees required to be paid by the petitioners have been duly paid.

Section 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota and of the territory affected; the real estate described herein abuts upon the city and is so conditioned as properly to be subjected to city government.


Section 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be, and the same is, hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section 7. This ordinance shall be final and take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, Town Clerk of Thomastown Township, Wadena County Auditor, and Minnesota Secretary of State.
