## ORDINANCE NO. 308

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES

The City Council of the City of Staples does ordain as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota by Lawrence L. Knosalla, Judy K. Knosalla, Peter J. Hengel, Louis C. Knosalla and Isabel Knosalla, as all of the owners of the following described real estate for the purpose of having such real estate included within the city limits of the City of Staples, Minnesota:

Commencing at the Southeast corner of the Northeast Quarter of the Southeast Quater (NE% of SE%) of Section 2, Township 133 North, Range 33 West; thence running due North 660 feet; thence due West 660 feet; thence due South 660 feet, thence due East 660 feet to the point of beginning (said tract being the South 10 acres of the East 20 acres of the NE% of SE% of Section 2, Township 133 North, Range 33 West), together with all abutting streets and alleys.

Section 2. The above described real estate is unplatted, and Lawrence L. Knosalla and July K. Knosalla are the owners of the East 5 acres of the above described real estate, and Peter J. Hengel, as contract for deed vendor, and Louis C. Knosalla and Isabel Knosalla, as contract for deed vendees, are the owners of the West 5 acres of the above described real estate.

Section 3. Notice of the filing of the petition has been filed with the Town Board of Staples Township, the Todd County Board of Commissioners, the Minnesota Municipal Commission, and the City of Staples at least 60 days prior to the first reading of this ordinance, and no objections to the petition have been received.

Section 4. All fees required to be paid by the petitioners have been duly paid.

Section 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota and of the territory affected; the real estate described herein abuts upon the city and is so conditioned as properly to be subjected to city government.

Section 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be, and the same is, hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section 7. This ordinance shall be final and take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, Town Clerk of Staples Township, the Todd County Auditor, and the Minnesota Secretary of State.


