ORDINANCE NO. 115

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS  
OF THE CITY OF WATERTOWN, CARVER COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF WATERTOWN, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. That pursuant to Minnesota Statutes, Section 414.003, Subdivision 2, (a), the City Council of the City of Watertown, having determined that those certain lands as hereinafter set forth are owned by the City of Watertown, abut the present corporate limits of the City of Watertown, are not included in any other municipality and are conditioned as properly to be subjected to municipal government, the corporate limits of the City of Watertown are hereby extended to encompass and include all that certain land described as follows:

The South 550.00 feet of that part of the Southeast Quarter of the Northwest Quarter of Section 4, Township 117, Range 25, lying easterly of the centerline of Carver County Road No. 27.

ALSO, the South 550.00 feet of that part of the Southwest Quarter of the Northeast Quarter of said Section 4, lying westerly of the Crow River.

Section 2. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Town Clerk of the Town of Watertown, the Carver County Auditor, and the Minnesota Secretary of State and to publish this Ordinance in the Carver County News, all as required by law.

Adopted by the City Council of the City of Watertown this 4<sup>th</sup> day of September, 1979.


