ORDINANCE: NO."713

An Ordinance Extending the Corporate Limits of the Cify of Willman, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Not exceeding 200 acres

WHEREAS, a petition has been filed with the governing body of the City of Willmar, a municipal corporation in the State of Minnesota, by the sole, owners having an interest therein, to have certain property hereinafter described included within the limits of the City of Willmar,

Minnesota, and

WHEREAS, it is proposed to annex by virtue hereof
to the said City of William, said property all of which
said property is in Kandiyohi County, Minnesota; and

WHEREAS, pursuant to Minnesota law, said land may be annexed by ordinance; and

WHEREAS, the said property to be annexed consists of approximately 1.23 acres, more or less, described as follows, to-wit:

The N. 132' of the S. 429' of the E. 405' of the SE'4 of SE'4 of Sec. 22, Township 119, Range 35, Kandiyohi County, Minnesota; Subject to State Trunk Highway No. 71 over the E'Ty 75'. thereof and subject to any easements of record.
Said tract contains 1.23 acres more or less including Highway Right-of-Way.

. WHEREAS, the Township of Willman has passed a resolution waiving the statutory 90 day waiting period and has consented to the immediate annexation of the within described land;

NOW, THEREFORE, the City Council of the City of

Willmar hereby determines, ordains and declares as follows:

Section 1. BEST INTEREST OF THE CITY OF WILLMAR AND AREA TO BE ANNEXED. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. ABUTS ON CITY LIMITS. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. ANNEXATION. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it has originally been a part thereof.

Section 4. ZONING. The area above described shall be zoned B-2, General Business...

Section 5. EFFECTIVE DATE. This Ordinance shall be filed and shall take effect and be of full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of State of Minnesota, and from and after its passage and publication.
