

ORDINANCE NO. 69

AN ORDINANCE ANNEXING CERTAIN UNPLATTED LANDS AND
EXTENDING THE CORPORATE LIMITS OF THE CITY OF NEW LONDON

The City Council of the City of New London does ordain as follows:

SECTION 1. Origination and Procedure. It having been deemed desirable by the City Council to annex certain unincorporated and unplatted land, the perimeter of which land is 60% or more bordered by the City of New London and which land comprises 40 acres or less, the City Council met on the 5th day of September, 1979, at which time a Resolution of the City Council was passed in accordance with Section 414.033, Subd. 3, of Minnesota Statutes, to annex the said land as a part of the municipality of New London and to adjust the corporate boundary accordingly. This annexation proceeding shall be deemed final upon filing of a copy of this Ordinance with the Minnesota Municipal Commission, the Kandiyohi County Auditor and Secretary of State of the State of Minnesota.

SECTION 2. Description. Lands subject to this annexation are in the Township of New London, County of Kandiyohi, State of Minnesota, described as follows, to-wit:

All that ~~part~~ of the Southeast Quarter of the Southeast Quarter of Section Nine, Township One Hundred Twenty-one, Range Thirty Four, lying South and East of the plat of Londonderry.

SECTION 3. Annexation. The City Council hereby determines that the perimeter of the land described herein is 60% or more bordered by the municipal limits of the City of New London and that the annexation will be in the best interest of the City and the land affected. Therefore, the area proposed for annexation is hereby annexed to, and included with the city limits as effectually as if it had originally been a part thereof.


SECTION 4. Effective Date. This Ordinance is deemed to be in full force and effect from and after its date of publication.

This ordinance passed this 5th day of September, 1979.




