



**ORDINANCE NO. 96**

**Section I**

An Ordinance extending the corporate limits of the City of Starbuck, Minnesota to include certain property petitioned by owners to be annexed.

**Section II**

The corporate limits of the City of Starbuck, County of Pope and State of Minnesota are hereby extended to include the property and territory in the County of Pope and State of Minnesota, described as follows:

All that part of the Northeast Quarter of the Northwest Quarter and All that part of Government Lots Two (2) and Three (3) of Section Twenty-five (25), Township One Hundred Twenty-five (125), Range Thirty-nine (39) which is described and enclosed within the following boundary lines, to-wit:

Commencing at the Northwest corner of Lot One (1) of the Plat of Teigen's Addition as the same is on file and of record in the office of the Pope County Recorder.

Thence North 74° 49' West 33.0 feet,

Thence South 14° 45' West 70.8 feet,

Thence South 34° 17' West 68.3 feet,

Thence South 61° 10' West 49.6 feet,

Thence South 18° 54' East 191.3 feet to the lakeshore of Lake Minnewaska; this point being the point of beginning of the tract herein described,

Thence North 18° 54' West 191.3 feet,

Thence North 61° 10' East 49.6 feet,

Thence North 34° 17' East 68.3 feet,

Thence North 14° 45' East 70.8 feet,

Thence North 00° 00' to the South right of way line of the Burlington Northern Railroad,

Thence in a Southwesterly direction along the said right of way line to the North and South Quarter line of said Section Twenty-five (25);

Thence South along the said Quarter line to the lakeshore of Lake Minnewaska;

Thence in a Easterly direction along the said lakeshore to be point of beginning.

Containing 24.0 acres, more or less.

**Section III**

The City Clerk is hereby directed to file copies of this ordinance as follows: One in the office of State of Minnesota Municipal Board, one in the office of the Pope County Auditor, one in the office of the Secretary of State of Minnesota and one in the office of the Clerk of White Bear Lake Township.

Annexation shall be effective from and after the date when copies of this ordinance have been filed as directed in Section III.
