CHAPTER 18.07

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ANNANDALE TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS.

WHEREAS, certain territory as hereinafter described is not presently included within the corporate limits of any incorporated city;

WHEREAS, the territory is completely surrounded on all sides by lands already included within the corporate limits of the City of Annandale and is deemed to be urban in character;

The City Council of the City of Annandale ordains:

Section 1. Territory Annexed. The corporate limits of the City of Annandale, Minnesota, are hereby extended to include the unplatted territory described below, which territory is now and was heretofore completely surrounded by territory already included within the city limits:

The Southeast One-quarter of the Northwest One-quarter of Section 29-121-27, Wright County, Minnesota.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Corinna Township, Wright County Auditor, and the Minnesota Secretary of State.

Section 3. Effective Date of Annexation. This ordinance shall take effect the date the ordinance is approved by the Minnesota Municipal Board.




