ORDINANCE NO.37 SECOND SERIES

AN ORDINANCE OF THE CITY OF LITTLE FALLS EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITTLE FALLS TO INCLUDE CERTAIN UNINCORPORATED, PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS AND AMENDING THE CITY CODE, SECTION 11.05, SUBD. 2, BEING THE ZONING MAP OF THE CITY OF LITTLE FALLS.

WHEREAS, A certain Petition for Annexation dated June 11, 1979

pertaining to the annexation of the premises hereinafter described was duly

presented by the Executive Council for the State of Minnesota to the Minnesota

Municipal Board on June 15, 1979, and

WHEREAS, The quantity of land embraced within the area described in the petition and bounded as described therein is 5,29 acres of platted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, The petition was signed by all property owners, and
WHEREAS, The City Council for the City of Little Falls at its meeting
held on July 16, 1979 approved the annexation of the land described in the
petition, and

WHEREAS, No objections to the annexation were received by the Minnesota Municipal Board from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to the annexed, and

WHEREAS, The land described in the petition abuts upon the corporate limits of the City of Little Falls, Morrison County, Minnesota, at the westerly boundary thereof,

THE CITY OF LITTLE FALLS ORDAINS:

Section 1. The City Council hereby determines: (1) that the annexation will be in the best interests of the City of Little Falls, Minnesota and of the territory affected; (2) that the territory described herein abuts upon the corporate limits of the City of Little Falls and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The territory hereby annexed consists entirely of platted land. All of this land lies entirely within the County of Morrison, State of Minnesota, and the description of such lands is as follows:

Tract A

That part of Lot 1 of Broadway Acre Lots of the City of Little Falls, according to the plat thereof now on file and of record in the office of the Register of Deeds in and for Morrison County, described as follows; Beginning at a point distant 668 feet north and 33 feet west of the southeast corner of section 13, township 129 north, range 30 west; thence north parallel with the east line of said section for 460 feet; thence deflect to the left at an angle of 90°00' for 297 feet; thence deflect to the left at an angle of 90°00' for 460 feet; thence deflect to the left at an angle of 90°00' for 297 feet to the point of beginning; containing 3.14 acres more or less.

Tract B

Lots 2 and 3 of Broadway Acre Lots to the City of Little Falls, according to the plat thereof on file and of record in the office of the County Recorder in and for Morrison County, Minnesota excepting therefrom that part lying south of a line drawn parallel to and 425 feet north of the center line of Trunk Highways Number 27 and 28 as now laid out and located;

Section 3. That the City Code, Section 11.05, Subd. 2, be and hereby is, amended by adding to the boundaries of Industrial District (Heavy) I 2 delineated on the Zoning Map of the City of Little Falls, which map is a part of said section of the City Code, the following described premises, to-wit:

Tract A

That part of Lot 1 of Broadway Acre Lots of the City of Little Falls, according to the plat thereof now on file and of record in the office of the Register of Deeds in and for Morrison County, described as follows; Beginning at a point distant 668 feet north and 33 feet west of the southeast corner of section 13, township 129 north, range 30 west; thence north parallel with the east line of said section for 460 feet; thence deflect to the left at an angle of 90°00' for 297 feet; thence deflect to the left at an angle of 90°00' for 297 feet to the point of beginning; containing 3.14 acres more or less.

Tract -F

Lots 2 and 3 of Broadway Acre Lots to the City of Little Falls, according to the plat thereof on file and of record in the office of the County Recorder in and for Morrison County, Minnesota excepting therefrom that part lying south of a line drawn parallel to and 425 feet north of the center line of Trunk Highways Number 27 and 28 as now laid out and located.

Section 4. The Zoning Administrator shall cause the Zoning Map of the City of Little Falls to be changed and amended so as to show the amendment provided in Section 3 hereof.

Section 5. This ordinance shall be added to Chapter 13 of the City Code under annexation and under Zoning Map Amendments.

Section 6. Filing. The Acting City Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Town Clerk, the Morrison County Auditor and the Secretary of State.

Section 7. Effective Date. This ordinance shall be in full force and effect seven (7) days after its publication.
