PETITION FOR ANNEXATION

TO THE COUNCIL OF THE CITY OF WABASSO, MINNESOTA:

The undersigned, being the sole owners of the territory described below, hereby request the council to annex this territory to the city and to extend the city boundaries to include the same, and for that purpose respectfully state:

1. The territory to be annexed consists entirely of lands which will be platted into lots and blocks. All of these lands lie entirely within the County of Redwood, Minnesota and the description of such lands is as follows:

All that tract or parcel of land situated in the Southwest Quarter (SWZ) of Section Twenty-four (24), Township One Hundred Eleven (111) North, Range Thirty-seven (37) West, Redwood County, Minnesota, described as follows: Commencing at a point 398 feet East and 547 feet North of the Southwest Corner of the Southwest Quarter (SW\(\frac{1}{4}\)) of Section Twenty-four (24), then West a distance of 220 feet, then North a distance of 171.5 feet, then West a distance of 178 feet to the West line of said Southwest Quarter, then North along said line a distance of 538 feet, then East a distance of 398 feet, then South a distance of 709.5 feet to the point of beginning, containing 5.78 acres more or less.

- 2. The territory described above abuts upon the city limits at the east boundary and south boudaries thereof and none of it is presently included within the corporate limits of any incorporated city.
- 3. All of the territory described above is situated in Vail Township.
- 4. All of this territory is or is about to become urban or surburban in character.
