Ordinance No. 12/

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PINE RIVER TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, or borough; and WHEREAS, this territory abuts upon the corporate limits of the city at the eastern boundary thereof and is deemed to be urban in character; and

WHEREAS, this terrtory is owned in fee by the city;

The City Council of Pine River ordains:

<u>Section 1.</u> <u>Territory annexed</u>. The corporate limits of the City of Pine River are hereby extended to include the unplatted property described as follows now owned by the city:

> The South Half of the Southwest Quarter $(S_2^{+} SW_2^{+})$ of Section Thirty-two (32), Township One Hundred Thirty-eight (138), Range Twenty-nine (29), except that portion thereof heretofore transferred by an instrument of conveyance on file and of record in the office of the County Recorder of Cass County, Minnesota, and recorded as Document No. 212672. Also excepting therefrom the following described property, viz: The East 416 feet of the West 931 feet of the South 312 feet of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{2}$ SW $\frac{1}{2}$) of Section Thirty-two (32), Township One Hundred Thirty-eight (138), Range Twenty-nine (29).

and

The Northwest Quarter of the Northwest Quarter (NW $\frac{1}{2}$ NW $\frac{1}{2}$), the East One-Half of the Northwest Quarter of the Southwest Quarter (E $\frac{1}{2}$ NW $\frac{1}{2}$ SW $\frac{1}{2}$), The West One-half of the Northeast Quarter of the Southwest Quarter (W $\frac{1}{2}$ NE $\frac{1}{2}$ SW $\frac{1}{2}$), and that portion of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) lying easterly of the following described line: Beginning at a point on the North line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) 360 feet East of the Northwest corner thereof and running southerly, parallel to the West line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) a distance of 675 feet, running thence easterly, parallel to the North line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) a distance of 165 feet; running thence southerly parallel to the West line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) to the South line thereof, and there terminating; all in Section Thirty-two (32), Township One Hundred Thirty-eight (138), Range Twenty-nine (29).

<u>Section 2.</u> <u>Filing</u>. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Commission.

<u>Section 3.</u> <u>Effective date of annexation</u>. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.
