I am herewith submitting a certified copy of Ordinance # 1.42 AN ORDINANCE ANNEKING CONTINGUOUS TERRITORY TO THE CITY OF PIPESTONE. This is pursuant to M.S. 414.033, Subd. 4 which states "if the land is completely surrounded by land within the municipal limits, the municipal council may by ordinance declare the land annexed to the municipality, and any such land is deemed to be urban in character".

I am enclosing a map showing the location of this 75' x 150' land parcel on 4th St. N.W. This Ordinance was published in our official newspaper on 10 November 1975. As I understand it, this annexation is final upon the filing of a copy of the ordinance with the Sweet Township Clerk, the Pipestone County Auditor, the Secretary of State, in addition to the Minnesota Municipal Commission. These filings are being mailed by this office today.
