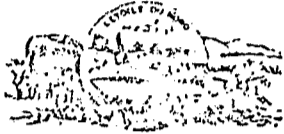

ORDINANCE NO. 32 , 2ND SERIES

AN ORDINANCE ANNEXING CERTAIN LANDS
IN ROCKSBURY TOWNSHIP
TO THE CITY OF THIEF RIVER FALLS.

THE CITY COUNCIL OF THIEF RIVER FALLS, MINNESOTA, ORDAINS:

Section 1. WHEREAS, the City of Thief River Falls has served notice of intent to annex the land hereinafter described on the Town Board of the Township of Rocksbury and on the Minnesota Municipal Board stating that the perimeter of the area of said tract is sixty percent (60%) or more bordered by the City of Thief River Falls, and is less than forty (40) acres and is not included in any other municipality and that it is the intent of the City of Thief River Falls to annex said property to said City by Ordinance in accordance with the provisions of statute, and

WHEREAS; no objections to the proposed annexation were forthcoming within ninety (90) days from the date of service thereof,

NOW, THEREFORE, It is hereby determined that the annexation of said premises will be to the best interest of the City of Thief River Falls and of the territory affected and the following described premises and they hereby are declared annexed to the City of Thief River Falls:

Real estate in the Township of Rocksbury, County of Pennington and State of Minnesota described as follows, to-wit:

A parcel of land which is part of Government Lots Two (2) and Three (3), Section Three (3), Township One Hundred Fifty-three (153) North, Range Forty-three (43) West bounded as follows:

Beginning at the Northeast corner of Southern Addition to Thief River Falls; thence South along the Easterly line of said Addition a distance of 750 feet; thence East a distance of 351.5 feet; thence South a distance of 650 feet more or less to the South line of said Government Lot 3; thence East along said South line to the Southwest corner of Allwood Acres Addition to Thief River Falls; thence North along the West line of said Addition to the South line of Greenwood Street; thence West along the South line of Greenwood Street to the point of beginning; containing 10.3 acres more or less.

Section 2. City Code, Chapter 20, listing of uncoded Annexation Ordinances is hereby amended by addition of the foregoing Ordinance to such listing.

Section 3. This Ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Board, the Town Clerk of Rocksbury Township, the Pennington County Auditor and the Secretary of State of the State of Minnesota.

Passed by the City Council of the City of Thief River Falls, Minnesota, this 13th day of November, 1979.


