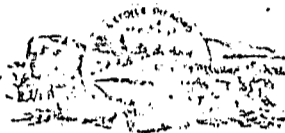

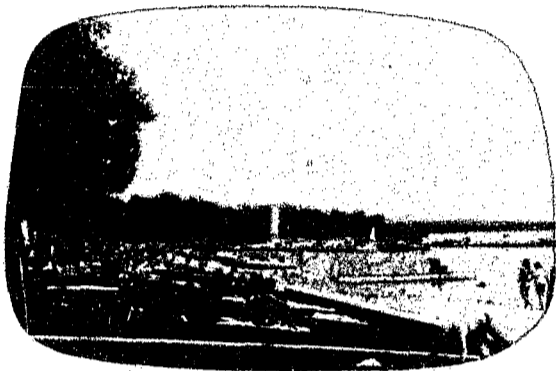

ORDINANCE NO. 375

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DETROIT LAKES, MINNESOTA
TO INCLUDE CERTAIN LANDS

THE COUNCIL OF THE CITY OF DETROIT LAKES, MINNESOTA, DOES ORDAIN:

Section 1. That the following described properties are more than 60% surrounded by the present municipal boundaries and should be included within the City of Detroit Lakes, Minnesota:

1. Beginning at the point of intersection of the centerline of the right-of-way of Trunk Highway No. 34 and the east line of Barbara Avenue extended northerly; thence South 0°11'25" East for a distance of 275.32'; thence North 89°57'09" East a distance of 121.90'; thence South 0°46'49" West a distance of 87.76'; thence South 89°06'24" East a distance of 14.67'; thence South 0°11'25" East a distance of 315.31'; thence North 89°48'34" East a distance of 96.16'; thence South 88°09'51" East a distance of 140' to the northeast corner of Lot 9, Block 2, Mountain View Second Addition; thence continuing on aforesaid bearing a distance of 66.10' to the east line of Laura Avenue; thence northerly on the east line of Laura Avenue to a point which is 290.41' north of the point of intersection of the east line of Laura Avenue and the north line of Central Street; thence east and parallel with the north line of Central Street for a distance of 198.47'; thence South to a point on the north line of Central Street, which point is 389.28' west of the west line of 11th Avenue; thence north on the west line of 11th Avenue to the centerline of the right-of-way of Trunk Highway No. 34; thence west on said centerline of Trunk Highway No. 34 to the point of beginning. (Approximately 15.88 acres.)

*Bearings on this description are on an assumed datum as shown on the plat of Mountain View Second Addition which is on file and of record in the office of the Register of Deeds in the Becker County Courthouse.

2. The NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 27, Township 139, Range 41W. (Contains approximately 40 acres.)
3. W $\frac{1}{2}$ Lot 6, Lots 7-19 and Lots 21-23, City View Beach. (Approximately 5.29 acres.)

Section 2. The City Council hereby determines that:

1. The annexation will be in the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected.
2. The territory described herein is so conditioned as property to be subjected to the city government.
3. The area to be annexed consists of approximately 61.17 acres, 6 residences occupied by 11 people, and the official population of the City of Detroit Lakes should include the additional 11 people.

Section 3. Therefore, the Council of the City of Detroit Lakes, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same hereby is annexed to and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Board, the County Auditor, the Secretary of State, and the Clerks of the Town Boards, and from and after its passage and publication.
