Section 8: The corporate limits of the City of St. Peter are hereby extended to include the property described in Section 1 and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof.

Section 9: The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, Traverse Township, Nicollet County Auditor and the Secretary of State.

Section 10: This Ordinance takes effect upon its passage, approval, publication, the filing of the certified copies as directed in the previous section and upon approval by the Minnesota Municipal Board.





ORDINANCE NO. 60, SECOND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ST. PETER TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND CONTAINING 1.03 ACRES MORE OR LESS.

THE CITY COUNCIL OF THE CITY OF SAINT PETER ORDAINS:

Section 1: An application for annexation has been filed with the governing body of the City of St. Peter, Minnesota, by all of the land owners in area and number of the following described real estate to have such property included within the City of St. Peter, Minnesota:

Commencing at the Northwest corner of the Southwest Quarter of Section 9, Township 110 North of Range No. 26 West; thence South along the West line of said Southwest Quarter a distance of 1318.8 feet; thence deflecting to the left at an angle of 88 degrees and 9 minutes a distance of 684.1 feet to an iron pipe, the place of beginning; thence Easterly along the same line a distance of 364 feet to the right-of-way line of Minnesota Trunk Highway No. 22; thence deflecting to the left at an angle of 150 degrees and 30 minutes along the Southerly line of said right-of-way for 500.4 feet to an iron pipe; thence South in a straight line 256.6 feet, more or less, to the point of beginning, containing about 1.03 acres.

Section 2: The quantity of land embraced within the foregoing description, and bounded as described, contains 1.03 acres of land more or less.

Section 3: The area proposed for annexation is unplatted.

Section 4: An affidavit has been filed with the City Clerk's Office stating that copies of the Intent to Annex have been filed with Minnesota Municipal Board and the Town Board of Traverse Township in which all of the land to be annexed is located.

Section 5: The 90 day period within which the town board shall have the right to object to the annexation has been waived by the town board and a copy of said waiver is on file with the Minnesota Municipal Board and the City Clerk's Office.

Section 6: The perimeter of the area to be annexed by the City is 60 percent or more bordered by the Municipality.

Section 7: The annexation will be to the best interest of the City of St. Peter.
