ORDINANCE NO. 165-2ND SERIES

AN ORDINANCE EXTENDING
THE CORPORATE LIMITS OF
THE CITY OF EAST GRAND
FORKS, TO INCLUDE CERTAIN
UNINCORPORATED TERRITORY COMPLETELY SURROUNDED (BORDERED) BY
LAND WITHIN THE CITY
LIMITS AND BY LAND WITHIN
THE CITY LIMITS AND ABUTTING THEREON.
WHEREAS, certain territory described below is not presently included
within the corporate limits of any incorporated city, or borough; and
WHEREAS, This territory is completely surrounded on all sides by
lands already included within the corporate limits of the city and is deemed to be urban or suburban in
character;
The city council of East Grand
Forks ordains:
SECTION 1. Territory annexed.
The corporate limits of the City of
East Grand Forks, Minnesota, are
hereby extended to include the unplatted territory, which territory now
is and has heretofore been completely
surrounded by territory already included within the city limits, described as follows:

A tract of land in Government
Lot 4 of Section 31, Township
152 North, Range 49 West of the
5th Principal Meridian, which
tract is described as follows, to-wit:
Commencing at the southwest
corner of Section 31, Township
152 North, Range 49 West of the
5th Principal Meridian and thence
proceeding northerly along the
West line of said Section 31, for a
distance of 116.00 feet; thence
proceeding easterly parallel to the
south line of said Section 31 for a
distance of 40.00 feet to the true
point of beginning; thence proceeding northerly parallel to the
aforesaid west line of Section 31;
for a distance of 450.00 feet more
or less to an intersection with a
line lying parallel to and 566.00
feet distant northerly from the
aforesaid south line of Section 31;

thence proceeding easterly along said line lying parallel to and 566.00 feet distant northerly from the south line of Section 31 for a distance of 484.00 feet; thence proceeding southerly parallel to the aforesaid West line of Section 31, for a distance of 450.00 feet to an intersection with a line lying parallel to and 116.00 feet distant northerly from the south line of the aforesaid Section 31; thence proceeding westerly along said line lying parallel to and 116.00 feet distant northerly from the south line of Section 31; for a distance of 484.00 feet, to the true point of Section 31, for a distance of 484.00 feet, to the true point of beginning, said described tract being comprised of approximately 5.00 acres in Government Lot 4 of Section 31, Township 152. North, Range 49 West of the 5th Principal Meridian, County of Polk, State of Minnesota.

SECTION 2, Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

SECTION 3. Effective date of amnexation. This Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.


