ORDINANCE NO. 694

ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MOORHEAD TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES IN AREA ABUTTING UPON THE CITY LIMITS AT THE NORTHERLY BOUNDARY THEREOF.

WHEREAS, a certain Petition requesting annexation of the land hereinafter described was duly presented to the Council; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is less than 200 acres of unplatted land no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the Petition was signed by all of the owners of the real estate involved; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City limits at the Northerly boundary of said city,

NOW, BE IT ORDAINED by the City Council of the City of Moorhead, as follows:

Section 1. The City Council does hereby determine (1) that the annexation will be to the best interest of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof, said land being described as follows:

Lot One (1), Block One (1), Roen's First Subdivision, a subdivision of Government Lot Five (5), Section Twentynine (29), and a part of Government Lot Two (2), Section Thirty-two (32), both in Township One Hundred Forty (140), Range Forty-eight (48), Clay County, Minnesota, except the following described tract: Commencing on the South line of Block One (1) of Roen's First Subdivision at the point of

intersection of the common line between Lot One (1) and Lot Two (2) of said Block One (1), thence North 89°43'44" West along said South line of said Block One (1) a distance of 164.55 feet; thence North 00°49'56" West a distance of 22.05 feet; thence North 89°44'47" West a distance of 215.00 feet; thence South 00°49'56" West a distance of 173.18 feet; thence North 89°44'47" West along said South line of said Block One (1) a distance of 463.64 feet to the point of beginning of the tract herein conveyed; thence South 89°44'47" East a distance of 463.64 feet; thence North 00°49'56" West a distance of 173.18 feet; thence North 89°44'47" West on a straight line to a point of intersection with the shoreline of the Red River of the North; thence Southwesterly along said shoreline to a point of intersection with the South line of said Block One (1); thence South 89°44'47" East 46.36 feet, more or less, to the point of beginning, being a part of Lot One (1), Block One (1), Roen's First Subdivision, a subdivision of Government Lot Five (5), Section Twenty-nine (29), and a part of Government Lot Two (2), Section Thirty-two (32), both in Township One Hundred Forty (140), Range Forty-eight (48), Clay County, Minnesota, said parcel to be annexed containing 9.5 acres, more or less.

Section 3. FILING. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. EFFECTIVE DATE. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
