# ORDINANCE NO. 6 - 1979 ORDINANCE TO ANNEX CERTAIN PROPERTY ADJOINING THE CITY OF PAYNESVILLE

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borrough; and

WHEREAS, this territory borders upon the city limits of the City of Paynesville and is deemed to be light industrial in character; and

WHEREAS, the property has access to city water and sewer and has been developed to some degree and is in a position for further development.

NOW, THEREFORE, the City Council of the City of Paynesville ordains:

Section 1. <u>TERRITORY ANNEXED</u>. The corporate limits of the City of Paynesville, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory is now and has heretofore been adjacent to the incorporated limits of the City of Paynesville:

The ordinance shall take effect upon passage and publication and the filing of certified copies as directed in Section 3 and approval pursuant to Minnesota Statutes. The City Council does, however, specifically ordain that taxes due and payable during the year 1979 shall be payable by the County Auditor to the Paynesville Town Board.
