ORDINANCE NO. 181

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF JANESVILLE, MINNESOTA TO INCLUDE CERTAIN UNPLATTED LANDS, NOT EXCEEDING 200 ACRES, PURSUANT TO M.S.A. SECTION 414.033, SUBD. 5, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MINNESOTA MUNICIPAL COUNCIL.

BE IT ORDAINED By the City Council of the City of Janesville, Minnesota:

SECTION I

A petition having been filed with the City Clerk of the City of Janesville by Sara L. Schueneman, as fee owner of the real estate hereinafter described, to have the said hereinafter described real estate located in Janesville Township, Waseca County, Minnesota, annexed to and included in the corporate limits of the City of Janesville, Waseca County, Minnesota, to-wit:

That part of the East 303.5 feet of the North 1161 feet of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$), which lies North of Gosper's Addition to the City of Janesville, as platted, except the East 50 feet thereof, all in Section Twenty-eight (28), Township One Hundred Eight (108) North, Range Twenty-four (24) West, Waseca County, Minnesota.

The property above described does not exceed 200 acres, and is land which abuts the City of Janesville, Minnesota.

Copies of the Petition for Annexation were duly filed with the Minnesota Municipal Council, the Janesville Town Board, and the Waseca County Board of Commissioners, according to information on file with the City Clerk. The Janesville Town Board and the Waseca County Board of Commissioners both having considered the matter and both having executed a separate Resolution approving

said annexation, and requesting that the Minnesota Municipal Council take all necessary steps to approve the annexation, the City Council of the City of Janesville, Minnesota subsequently considered the matter, and did determine that the annexation of the above described property to the City of Janesville is in the best interests of said municipality.

SECTION II

The tract of land situated in Janesville Township, Waseca County, Minnesota specifically described in Section I above, is hereby annexed to the City of Janesville, County of Waseca and State of Minnesota.


