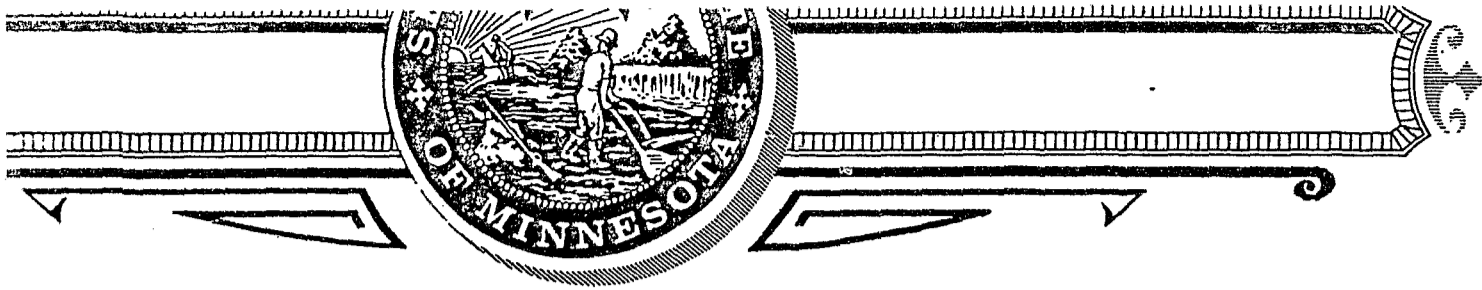

- EAS: These facilities contribute to the public good by providing individualized rehabilitative, social and spiritual services, as well as medical and nursing care; and
- EAS: The Minnesota Association of Health Care Facilities demonstrates significant leadership in providing total quality care through the development of standards, peer review, insistence of professionalism, and its continuing education programs; and
- EAS: The Minnesota Association of Health Care Facilities is participating in the observance of National Nursing Home Week under the sponsorship of the American Health Care Association;

THEREFORE, I, Albert H. Quie, Governor of the State of Minnesota, do hereby proclaim the month of May, 1980 to be
