ORDINANCE NO. 353

BEING AN ORDINANCE RELATING TO THE ANNEXATION TO THE CITY OF LE SUEUR OF CERTAIN LANDS SITUATED IN RURAL OTTAWA TOWNSHIP, LE SUEUR COUNTY, MINNESOTA.

The City of Le Sueur does ordain:

Section 1. That pursuant to the provisions of M.S.A. 414.033, Subd. 5 and upon a finding by the Common Council that such property is about to become urban in character the following described lands are hereby annexed by the City of Le Sueur and shall henceforth be included within and be a part of the corporate limits of the City of Le Sueur, Minnesota, to-wit:

That part of the Southwest Quarter of the Southwest Quarter of Section 1, Township 111 North, Range 26 West, Le Sueur County, Minnesota, described as follows, to-wit:

Commencing at the Southwest corner of the Southwest Quarter of the Southwest Quarter of Section 1; thence East along the South line of the Southwest Quarter of the Southwest Quarter of said Section 1 a distance of 350 feet to the point of beginning; thence proceeding North 0°00' East (assumed bearing) along a line parallel to the West line of the Southwest Quarter of the Southwest Quarter of said Section 1 a distance of 496.23 feet to a point; proceeding thence Northerly 89°46' East 75 feet to a point; proceeding thence South 0°00' West 496.23 feet, more or less, to the South line of the Southwest Quarter of the Southwest Quarter of said Section 1; thence Westerly along said South line 75 feet to the point of beginning.

Section 2. All Ordinances and portions of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.


Section 3. This Ordinance shall be in full force and shall take effect from and after its passage, publication and after filing copies hereof with the Minnesota Municipal Board, the Le Sueur County Auditor, Secretary of State of the State of Minnesota, the Town Board for Ottawa Township and final approval by the Minnesota Municipal Board and after compliance with any and all other provisions of applicable law.


