

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE (CITY) OF MANKATO TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a petition requesting annexation of the territory hereinafter described was duly presented to the City Clerk on the 28th day of January, 1980; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 1.73 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by the following owners:

C & S Supply Company, Inc., a Minnesota Corporation, and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the City limits at the northern boundary thereof;

NOW, THEREFORE, BE IT RESOLVED, that the City of Mankato, Minnesota, ordains: (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is or is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough; (4) that the corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Beginning at the intersection of Second Street North and the north right of way line of Dukes Street, thence northerly along the center line of North Second Street to the north line of Dukes Park Addition to the City of Mankato, thence easterly along said line of Dukes Park Addition to the center line of North Broad Street, thence southerly along the center line of North Broad Street to the north right of way line of Dukes Street, thence west along the north right of way line of Dukes Street to the point of beginning. Said property contains all of Block 41, Dukes Park Addition and all or portions of the rights of way of abutting streets. (5) The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor. (6) That this ordinance takes effect upon its passage and publication and the filing of the certified copies as directed.
