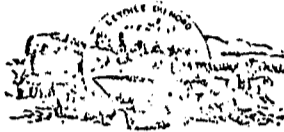



ORDINANCE NO. 435

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LANDS INTO THE CITY OF ORTONVILLE, MINNESOTA.

The City Council of the City of Ortonville, Minnesota, does ordain:

Section 1. That it will be for the best interest of the City of Ortonville that the annexation herein be granted.

Section 2. That the following described premises completely surrounded by the municipal corporate limits of the City of Ortonville, Minnesota, be and are hereby annexed and brought within the corporate limits of the City of Ortonville, Minnesota, to-wit:

Lot A of the Northeast Quarter of the Southwest Quarter (NE  $\frac{1}{4}$  SW  $\frac{1}{4}$ ) of Section Four (4), Township One Hundred Twenty-one (121), Range Forty-Six (46)

AND

All of the unplatted portion of the North Half of the Southwest Quarter (N  $\frac{1}{2}$  SW  $\frac{1}{4}$ ) of Section Four (4), Township One Hundred Twenty-one (121), Range Forty-six (46)

Section 3. This Ordinance shall be in force and effect from and after its passage and publication according to law.
