



Proposed Ordinance No. 3/80

ORDINANCE NO. 739

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF OWATONNA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a petition of 100% of the owners of the property herein described asks annexation of the said described property to the City of Owatonna; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 57.23 acres, more or less, no part of which is included within the limits of an incorporated city; and

WHEREAS, on September 11, 1979, a copy of said petition was sent to the Owatonna Township Board of Supervisors, Steele County Board of Commissioners and the Minnesota Municipal Board; and

WHEREAS, the Township of Owatonna has withdrawn its previously entered objection; and

WHEREAS, the City of Owatonna is a city of the third class operating under a Home Rule Charter adopted pursuant to the provisions of the Constitution and Laws of the State of Minnesota.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF OWATONNA DO ORDAIN:

SECTION 1. The City Council hereby determines:

1. That the annexation will be to the best interest of the City of Owatonna and of the property affected.
2. The property described herein abuts immediately upon the corporate limits of the City of Owatonna and is suitably conditioned for and needs urban government.
3. That none of said territories are now included within the limits of the City.

SECTION 2. That the following described property, referred to in the preamble of this ordinance, situate in the County of Steele, State of Minnesota, to-wit:

Commencing five hundred fifty-three (553⁰) feet north of the southwest corner of the northeast quarter (NE $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) of Section four (4), Township 107 North, Range 20 West, thence north one thousand six hundred and twenty feet (1620⁰); thence east to the westerly right of way line of the Chicago, Rock Island and Pacific Railroad, thence southeasterly along the said westerly right of way line to an iron monument on a line parallel with and five hundred fifty-three feet (553⁰) north of the south line of the northeast quarter (NE $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) of Section four; thence continuing southeasterly along the westerly line of the railroad right of way three hundred forty-four and fifty-eight one hundredths feet (344.58⁰) to an iron monument; thence west sixty-one and three-tenths feet (61.3⁰);

thence south two hundred and thirty and fifty-seven one hundredths feet (230.57'); thence west two hundred and ninety and five tenths feet (290.5') to the southwest corner of lot five (5) and continuing west five hundred and eighty-two and fifty-two one hundredths feet (582.52'); thence north five hundred and fifty-three feet (553') to a point on a line east of the point of beginning; thence west approximately seven hundred thirty-seven and forty-eight one hundredths feet (737.48') to the point of beginning, containing approximately fifty-seven and twenty-three one hundredths (57.23) acres.

be and the same hereby is annexed to the City of Owatonna and shall, upon the effective date of this ordinance, become a part of the City of Owatonna as effectively as if it had been originally a part thereof, and the corporate limits of said City of Owatonna are hereby extended to include said unplatted land.

SECTION 3. The Zone Class I-2 shall be applied to the lands herein described.

SECTION 4. This ordinance is enacted pursuant to the provisions of Minnesota Statutes, Chapter 414, Section 414.033, Subd. 5 and Subd. 6.

SECTION 5. Upon its adoption, approval and publication, a certified copy of this ordinance shall be filed with each of the following:

Steele County Auditor
Minnesota Secretary of State

as provided by law.

SECTION 6. This ordinance shall take effect upon its passage, publication and filing of the certified copies as provided hereinabove.


