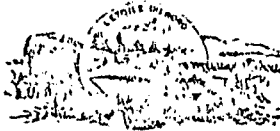



ORDINANCE # *Chapter 225*

AN ORDINANCE TO ANNEX TO THE CITY
OF STEPHEN CERTAIN LANDS OWNED BY
EARL HVIDSTEN AND GLORIA HVIDSTEN

The City Council of the City of Stephen, Stephen, Minnesota,
ordains as follows:

1. That Earl Hvisten and Gloria Hvidsten are the sole owners of certain real estate located in Marshall County and legally described as Potatoe Patch, an addition to the City of Stephen.
2. That Earl Hvidsten and Gloria Hvidsten have filed a petition with the City of Stephen, asking that the City of Stephen annex the above described property to the City of Stephen.
3. That said land does not exceed 200 acres.
4. That said land abuts the City of Stephen and is urban in character.
5. That the annexation of said real estate is in the best interest of the City of Stephen and is in the best interest of the above described real estate.
6. The City of Stephen hereby ordains and declares that the real estate described as Potatoe Patch, an addition to the City of Stephen be and the same hereby is annexed to and included in the City of Stephen, Stephen, Minnesota, as effectively as if it had originally been a part thereof.
7. This ordinance shall be final and shall be effective upon its publication and after filing a copy of the ordinance with the Minnesota Municipal Commission, the Town Clerk, the County Auditor, and the Secretary of State.
