CITY OF LITCHFIELD

ORDINANCE NO. 420

AN ORDINANCE extending the corporate limits of the City of Litchfield, Minnesota to include certain unincorporated, unplatted land not exceeding forty (40) acres in area abutting upon and bordered by sixty percent (60%) of the City limits of the City of Litchfield.

WHEREAS, the quantity of land embraced within the area hereinafter described is less than forty (40) acres;

WHEREAS, the perimeter of the area hereinafter described is sixty percent (60%) or more bordered by the limits of the City of Litchfield;

WHEREAS, notice of intent to annex said land has been served upon the Litchfield Town Board and Municipal Board from whom no objections to annexation have been received; and

WHEREAS, the land hereinafter described for annexation is sixty percent (60%) or more bordered by the City of Litchfield;

The Council of the City of Litchfield, Minnesota, ordains:

SECTION I.

The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected ; (2) that the territory described herein abuts upon sixty percent (60%) or more of the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

SECTION II. Territory Annexed.

The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included with the City as effectively as if it had originally been a part thereof; Land in Meeker County, Minnesota, to-wit:

The Easterly Two Hundred (200) feet of the Westerly Six Hundred Thirty-Seven (637) feet of the Northeast Quarter (NE 1/4) of Section Thirteen (13), Township One Hundred Nineteen (119), Range Thirty-one (31) of Meeker County, Minnesota, lying Northeasterly of the Northeasterly right-of-way line of U. S. Highway No. 12, subject to any easements of record.

Part of the North Half of the Northeast Quarter (N 1/2 NE 1/4) of Section Thirteen (13), Township One Hundred Nineteen North (119-N), Range Thirty-one West (31-W) described as follows: Beginning at a point 292.0 feet East and 241.1 feet South of the Quarter (1/4) corner of the North side of said Section Thirteen (13), thence due East 145.0 feet, thence South 195.5 feet to a point on the northerly 50 foot right-of-way line of Trunk Highway No. 12, thence in a northwesternly direction along said right-of-way line a distance of 151.3 feet, thence North 151.1 feet to point of beginning, containing 0.65 acre.


SECTION III. Filing.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission Board, Litchfield Township, Meeker County, Minnesota, the Meeker County Auditor and the Secretary of State.


SECTION IV. Effective Date.

This Ordinance takes effect upon its passage and publication and filing of certified copies as directed in Section III.
