AN ORDINANCE ANNEXING CERTAIN LANDS
AND PREMISES TO THE CITY OF LITCHFIELD
AND INCORPORATING SAID LANDS AND PREMISES
WITHIN THE CORPORATE BOUNDARIES OF THE

CITY OF LITCHFIELD, COUNTY OF MEEKER, STATE OF MINNESOTA

WHEREAS, a certain petition dated December 6, 1979, requesting annexation of the territory hereinafter described was duly presented and served on the City Council of the City of Litchfield on the 20th day of December, 1979; and

WHEREAS, the land described does not exceed two hundred (200) acres in area and no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners of said land; and
WHEREAS, a copy of said petition and notice of hearing thereon was served on the
Townships of Litchfield, Township of Darwin of Meeker County, Minnesota and the
Meeker County Auditor and the Minnesota Municipal Board; and

WHEREAS, no objections to the annexation have been received from the Litchfield
Town Board, the Meeker County Board of County Commissioners, and the objections of
the Darwin Town Board having been withdrawn the Municipal Board of the State of
Minnesota approved the annexation of said land, which abuts the boundaries of the City
of Litchfield, to be annexed by the City of Litchfield by ordinance in accord with statutes
provided;

NOW THEREFORE, the Council of the City of Litchfield, Meeker County, Minnesota, ordains:

#### Section I.

The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the land affected; (2) that the land described herein is owned entirely in fee by the petitioners and is urban or suburban in character; and (3) that none of said land is now included within the limits of any city, village or borough.

# Section II. Land Annexed.

The corporate limits of the City are hereby extended to include the unplatted land

described as follows and the same is hereby annexed to and included with the City as effectively as if it had originally been a part thereof and described as follows, to-wit:

A part of the Northeast Quarter (NE 1/4) of Section Thirteen (13), Township One Hundred Nineteen North (119-N), Range Thirty-one West (31-W) and a part of the West Half of the Northwest Quarter (W 1/2 NW 1/4), (sometimes referred to as Government Lots One (1) and Two (2)), and the Northeast Quarter of the Northwest Quarter (NE 1/4 NW 1/4) of Section Eighteen (18), Township One Hundred Ninetten North (119-N), Range Thirty West (30-W), described as follows to-wit: Beginning at the intersection of the West right-of-way line of County Aid Road no. 34, if extended, and the centerline of State Highway No. 12, thence in a Southeasterly direction along the centerline of said State Highway No. 12, a distance of 1,225.0 feet, thence in a Northeasterly direction and perpendicular to said centerline of State Highway No. 12 a distance of 710.0 feet; thence Northwesterly and parallel to the centerline of State Highway No. 12 to the West right-of-way line of County Aid Road No. 34, thence Southerly along the West right-of-way line of County Aid Road No. 34 to the point of beginning.

# Section III. Filing.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Board of the State of Minnesota, Litchfield Township and Darwin Township of the County of Meeker, Minnesota, the Meeker County Auditor and the Secretary of State.

#### Section IV. Effective Date.

This Ordinance takes effect upon its passage and publication and filing of certified copies as directed in Section III.

Adopted by the Council and passed unanimously on this 5thday of May, 1980.
