## ORDINANCE NO. 43, SECOND SERIES

AN ORDINANCE ANNEXING TO THE CITY OF ST. PETER 1,425 SQUARE FEET OF LAND LOCATED IN TRAVERSE TOWNSHIP, NICOLLET COUNTY, SECTION 9, TOWNSHIP 110 NORTH, RANGE 26 WEST.

The City Council of the City of St. Peter ordains:

Section 1: The following tract of land, consisting of 1,425 square feet of land, unincorporated and unplatted, owned by the City of St. Peter and completely surrounded by land within the City of St. Peter, is hereby declared by the City Council to be annexed to the City and pursuant to Minn. Stats. 414.033, said land is deemed to be urban in character. The tract of land is described as follows:

Commencing at the Northwest corner of the Southwest quarter of the Southwest quarter of Section 9; thence South 00 degrees 20 minutes 12 seconds West (assumed bearing) along the West line of the Southwest quarter of Section 9, a distance of 314.00 feet, thence North 88 degrees 40 minutes 57 seconds East, and parallel with the North line of the Southwest guarter of the Southwest quarter of Section 9, a distance of 380.02 feet to the northeasterly corner of Lot 2, Block One, Petrie Subdivision, said point being the point of beginning; thence continuing North 88 degrees 40 minutes 57 seconds East, along the last described line, 28.60 feet to a point on the westerly right of way line of the abandoned Chicago and Northwestern Railroad, said point being on a circular curve which center of radius bears South 72 degrees 14 minutes 00 seconds West; thence northwesterly along said westerly right of way line of the abandoned railroad along a 1860.00 foot radius curve, central angel = 02 degrees 35 minutes 00 seconds, an arc distance of 83.86 feet; thence South 54 degrees 21 minutes 09 seconds West, not tangent to said curve, 16.95 feet to a point on a circular curve which center of radius bears South 54 degrees 21 minutes 09 seconds West; thence southeasterly along a 68.01 foot radius curve, central angle = 35 degrees 59 minutes 03 seconds, an arc distance of 42.71 feet to the point of tangency of said curve; thence South 00 degrees 20 minutes 12 seconds West, along the tangent of said curve, 30.00 feet to the point of beginning. Said tract contains 1,425 square feet.

Section 2: The annexation will be to the best interest of the City of St. Peter.

Section 3: The corporate limits of the City of St. Peter are hereby extended to include the property described in Section 1, and the same is hereby annexed and included within the City as if it had originally been a part thereof.

Section 4: All the provisions of Chapter 1 of the St. Peter City Code are made a part hereof and applicable to this Ordinance.

Section 5: The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Nicollet County Auditor and the Traverse Township Clerk.


