(3) Said newspaper has 25 percent of its news column devoted to news of local interest to the community which it purports to serve and does not wholly duplicate any other publication and is not made up entirely of patents, plate matter and advertisements. (6) Said newspaper files a copy of each issue immediately with the State Historical Society. (7) Said newspaper has complied with all the foregoing conditions for at least two years preceding the day or dates of publication mentioned below. (8) Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1966, and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the managing officer of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.

The Southwest One-quarter of the Northeast One-quarter (SW 1/4 NE 1/4), and all of that part of Government Lot One (1), Section Twelve (12), Township Forty-four (44), Range Twenty-eight (28), lying and being North and West of the Northwestern line of Trunk Highway 16 and North of the center line of Garrison Creek, subject to Highway right-of-way easements.
Section 2. The ordinance shall take effect and be in force one week from and after its publication.
