ORDINANCE NO. 80-6-2-3

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LONG
PRAIRIE TO INCLUDE CERTAIN UNINCORPORATED, PLATTED LAND ABUTTING UPON THE
CITY LIMITS.

WHEREAS, certain petitions dated February 21,1980 requesting annexation of territory hereinafter described, was duly presented to the Council on the 3rd day of March 1980 and

WHEREAS, the quantity of land embraced within the area described in the petitions and bounded as described is less than two hundred (200) acres of platted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petitions were signed by all the owners of said property, and, WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the land to be annexed, and

WHEREAS, the Town Board has waived any and all objections on its part to the annexation, and

WHEREAS, copies of said petitions were filed with the Municipal Commission of the State of Minnesota, the County Auditor of Todd County and the Town Clerk of Long Prairie Township on February 26, 1980, and

WHEREAS, the land described in the petitions abuts upon the city limits at the south boundary thereof,

THE COUNCIL OF THE CITY OF LONG PRAIRIE, MINNESOTA,

## ORDAINS:

Section 1. The City Council hereby determines:

- (a) That the annexation will be to the best interest of the City and of the territory affected.
- (b) That the territory described herein abuts the city limits and is urban or suburban in character.

.(c) That none of the territory is now included within the limits of any city, village or borough.

Section 2. <u>Territory Annexed</u>: The corporate limits of the City are hereby extended to include the platted land described as follows, and the same is hereby annexed to and included in the City as effectually as if it had originally been a part hereof:

A part of the Southeast Quarter of the Northeast Quarter (SE½NE½). Section Nineteen (19), Township One Hundred Twenty-Nine, (129), North, Range Thirty-Three (33) West of the 5th P.M., more particularly described as follows, to-wit: To find the point of beginning commence at the Southeast corner of Said SE½NE½; thence on an assumed bearing of S89°52'14"W and along the South line of said SE½NE½, 597.0 feet to the point of beginning; thence from the point of beginning and continuing along said South line S89°52'14"W 714.66 feet to the Southwest corner of said SE½NE½; thence N00°04'17"W and along the West line of said SE½NE½ 962.37 feet; thence N89°42'35"E 432.89 feet; thence N00°02'16"W 358.26 feet to the North line of said SE½NE½; thence N89°42'35"E and along said North line 559.90 feet; thence S03°28'17"E 354.24 feet; thence N89°16'42"E 297.10 feet to the East line of said SE½NE½; thence S00°06'18"E and along said East line 654.10 feet; thence S89°52'14"W 597.0 feet; thence S00°06'18"E 318.75 feet to the point of beginning and containing 29.4 acres more or less, subject to existing County road right of ways.

Section 3. <u>Filing</u>. The City Clerk/Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. <u>Effective Date</u>. This ordinance takes effect upon its passage, publication and filing of the certified copies as directed in Section 3.
