RESOLUTION NO. 80-61

The City of West Saint Paul pursuant to the provisions of Chapter 341, of the Minnesota Laws of 1980, hereby resolves that commencing January 1, 1981, the employee-member contribution to the West Saint Paul Police Relief Association for retirement, disability and survivorship benefits shall be 8% of the maximum salary from which said benefits are determined.

It is further resolved that subject to the requirements, qualifications and limitations of Section 4, Subd. 4, of Chapter 607, of the Minnesota Laws of 1980, the City of West Saint Paul hereby approves the limited automatic post retirement adjustment for active and retired members of the West Saint Paul Police Relief Association authorized by Subd. 4 of said Law.

It is additionally resolved that instead of the longevity increase authorized by Section 4, Subd. 3, of Chapter 607, of the Minnesota Laws of 1980, and in place and in lieu thereof any active member of the West Saint Paul Police Relief Association shall be entitled to receive a partial service pension upon attaining the age of fifty years if the member after the probationary period has completed at least ten years of service as a police officer in the police department of the City of West Saint Paul. Such service pension shall be in an amount that is in proportion to the 20-year service pension that the member's months of service, exclusive of any probationary period, bears to 240 months. This 10-year vesting shall only apply to members who terminate active service or duty after the adoption of this resolution and the pension shall be deferred if the member terminates active service prior to attaining the age of fifty years. A member retiring with ten or more years of service shall be entitled to the automatic post retirement adjustments approved herein.
