

AN ORDINANCE EXTENDING
THE CORPORATE LIMITS OF
THE CITY OF EAST GRAND
FORKS TO INCLUDE CERTAIN
UNPLATTED LANDS IN SECTION SEVEN (7), TOWNSHIP

(151) NORTH, RANGE FORTYNINE (49) WEST OF THE FIFTH
PRINCIPAL MERIDIAN, POLK
COUNTY, MINNESOTA, NOT
EXCEEDING 200 ACRES, WHICH
TRACT CONTAINS 33.72
ACRES.

Section 1. A Polition has been filed

The City Council of the City of East Grand Forks, Minnesota, does ordain:

Section 1. A Petition has been filed with the City Council of the City of East Grand Forks, Minnesota by Park West, Ltd., a North Dakota Corporation; Clifford P. Smart and Irene A. Smart, husband and wife; and First Federal Savings and Loan Association of Crookston, being all of the owners of the land hereinafter described, to have such land included within the City limits of the City of East Grand Forks, Minnesota; that copies of said Petition were filled with the Minnesota Municipal Commission, the Town Board of Huntsville Township and the County Board of Polk County, Minnesota; that more than 60 days have elapsed since such filings of said petition, and that no objections have been filled as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:
