

ORDINANCE NO. 173-2ND SERIES

AN ORDINANCE EXTENDING
THE CORPORATE LIMITS OF
THE CITY OF EAST GRAND
FORKS TO INCLUDE CERTAIN
UNINCORPORATED TERRITORY BORDERED BY LAND
WITHIN THE CITY LIMITS AND
ABUTTING THEREON
WHEREAS, certain territory described below is not presently included
within the corporate limits of any incorporated city, or borough and
WHEREAS, 60 percent or more of
the perimeter of this territory is
bordered by lands already included
within the corporate limits of the city
and is deemed to be urban and suburban in character;
The City Council of East Grand
Forks ordains:
Section 1. Territory annexed. The
corporate limits of the City of East
Grand Forks, Minnesota, are hereby
extended to include the unplatted
territory described as follows:
A tract of land in the Northwest

A tract of land in the Northwest Quarter of Section 35, Township 152 North, Range 50 West of the Fifth Principal Meridian, which tract is described as follows, to-wit:

Commencing at the Northwest corner of Section 35, Township 152 North, Range 50 West of the Fifth Principal Meridian and thence proceeding easterly along the north boundary of said Section 35 on an assumed bearing of South 89°47' 21" East, for a distance of 998.16 feet to the true point of beginning; thence continuing South 89°47' 21" East along the said north boundary of Section 35 for a distance of 260.00 feet to the northwest corner of Wurden's Seventh Addition to the City of East Grand Forks, Minnesota; thence proceeding South 0°02'16" East along the west boundary of the said Wur-

den's Seventh Addition for a distance of 957.32 feet, to the southwest corner of said Wurden's Seventh Addition; thence proceeding South 89°57'45" West for a distance of 260.00 feet; thence proceeding North 0°02'15" West for a distance of 958.09 feet to the true point of beginning; said described tract comprised of 5.716 acres.

Section 2. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective date of annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.

Section 4. This Ordinance shall take effect and be in force from and after its passage and publication and be given the number 173-2ND SERIES.
