Ordinance No. 185

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY OF LEROY, MN:

WHEREAS, all the owners of the premises hereinafter described have petitioned the City Council of the City of LeRoy, MN. that said premises be annexed to the corporate limits of the City of LeRoy, Minnesota and that said premises are contiguous to and adjoining the City of LeRoy, and subject to incorporation within the corporate limits of LeRoy, Minnesota by petition to the governing body of the City of LeRoy, and

WHEREAS, due notice has been given to the Township of LeRoy, and Commissioners of Mower County and the Municipal Board of the State of Minnesota,

NOW THEREFORE, The City Council of the City of LeRoy, Mower County, Minnesota do ordain:

Section 1. The land hereinafter described shall be added to and incorporated within the corporate limits of the City of LeRoy, MN. and said City Council does hereby declare said premises hereinafter described to be incorporated within and to be a part of the City of LeRoy, described as follows:

That portion of Outlot 26 north and east of The Milwaukee Road right-of-way and lying south of Trunk Highway 56, with an area of 3.82 acres, all lying within Sec. 28-Twp. 101N, Range 14W, LeRoy Township, Mower County, MN.
