ORDINANCE NO. 738

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WILLMAR, A MUNICIPAL CORPORATION OF THE STATE OF MINNESOTA, TO INCLUDE CERTAIN LANDS NOT EXCEEDING 40 ACRES.

WHEREAS, the Township of Willmar has requested that the City of Willmar annex certain lands abutting the City limits of the City of Willmar and more than sixty (60%) percent surrounded by the City limits of the City of Willmar; and

WHEREAS, Minnesota Statute Section 414 et. seq. allows for annexation by ordinance of tracts of land abutting the City limits and sixty (60%) percent or more surrounded by the City; and

WHEREAS, it is proposed to annex by this ordinance to the City of Willmar, said property all of which is located in Kandiyohi County, Minnesota; and

WHEREAS, the property to be annexed consists of approximately 32.55 acres, more or less, described as follows, to-wit:

Tract One (1) - All of the Southeast Quarter of the Northeast Quarter of Section 21, Township 119 North, Range 35 West, lying south of West Park 3rd and 4th Additions to the City of Willmar, Minnesota, containing 26.58 acres, more or less.

Tract Two (2) - All of the Northwest Quarter of the Southeast Quarter of Section 21, Township 119 North, Range 35 West, lying north of Yorktown Estates Addition to the City of Willmar, Minnesota, containing 5.97 acres, more or less.

NOW, THEREFORE, the City Council of the City of Willmar does hereby ordain as follows:

Section 1. Best Interest of the City of Willmar and Area to be Annexed. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. Sixty (60%) Percent Surrounded. That the property above described is more than Sixty (60%) percent surrounded by the City limits of the City of Willmar.

Section 4. Annexation. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. Zoning. The parcel above-described shall be zoned R-2, one and two family residential district.

Section 6. Effective Date. This Ordinance shall be filed and shall take effect and be of full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
