



Proclamation

WHEREAS: THE STATE OF MINNESOTA HAS A VITAL INTEREST IN THE SCHOOLS OF LAW FROM WHICH GRADUATE FUTURE ATTORNEYS, JUDGES, BUSINESSMEN AND WOMEN, AND PUBLIC OFFICIALS; AND

WHEREAS: HAMLIN UNIVERSITY SCHOOL OF LAW, ALTHOUGH A RELATIVELY YOUNG SCHOOL, IS WIDELY RECOGNIZED FOR HIGH STANDARDS OF EXCELLENCE IN ITS EDUCATIONAL PROGRAM AND FOR THE COMPETENCE OF ITS GRADUATES; AND

WHEREAS: HAMLIN UNIVERSITY SCHOOL OF LAW IS FULLY ACCREDITED BY THE STATE OF MINNESOTA AND THE AMERICAN BAR ASSOCIATION, AND PRESENTS ADVANCED LEGAL EDUCATION COURSES AND SEMINARS WHICH LAST YEAR SERVED MORE THAN 8,000 MINNESOTA ATTORNEYS AND JUDGES; AND

WHEREAS: THE HAMLIN UNIVERSITY SCHOOL OF LAW WILL BE DEDICATING ITS NEW BUILDING ON OCTOBER 3, 1980, AND CEREMONY PARTICIPANTS WILL INCLUDE A NUMBER OF DISTINGUISHED PERSONALITIES FROM VARIOUS BACKGROUNDS AND AREAS OF EXPERTISE;

NOW, THEREFORE, I, ALBERT H. QUIE, GOVERNOR OF THE STATE OF MINNESOTA, DO HEREBY PROCLAIM OCTOBER 3, 1980 TO BE

HAMLIN UNIVERSITY SCHOOL OF LAW DAY

IN MINNESOTA, AND HAVE ASKED LIEUTENANT GOVERNOR LOU WANGBERG TO PREPARE THIS PROCLAMATION FOR MY SIGNATURE AND DISSEMINATE THE SAME.

IN WITNESS WHEREOF, WE HAVE HEREUNTO SET OUR HANDS AND CAUSED THE GREAT SEAL OF THE STATE OF MINNESOTA TO BE AFFIXED THIS TENTH DAY OF SEPTEMBER IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND EIGHTY AND OF THE STATE THE ONE HUNDRED TWENTY-SECOND.
