ORDINANCE NO. 70

AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED UNPLATTED LAND ABUTTING UPON THE CITY LIMITS OF THE CITY OF NEW YORK MILLS AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF NEW YORK MILLS TO INCLUDE THE SAME.

The City Council of the City of New York Mills, Minnesota do ordain as follows:

Section 1. The City Council hereby determines (1) that annexation of the hereinafter described territory will be in the best interests of the city and of the territory affected; (2) that the hereinafter described territory abuts upon the city limits and is about to become urban in character through the platting thereof into residential lots; (3) that none of said territory abuts upon or is included within the limits of any other city; and (4) all of the owners of any interest in said territory have petitioned this council for the annexation of said territory by the City of New York Mills and for extending the corporate limits of the City of New York Mills to include the same.

Section 2. Territory annexed. The corporate limits of the City of New York Mills are hereby extended to include the unplatted land described as follows:

The Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section 17, Township 135, Range 37, except (i) the east 825 feet of the north 264 feet thereof; (ii) the north 225 feet of the west 183 feet thereof; and (iii) the north 853 feet of the south 923 feet of the west 183 feet thereof; but subject to the right-of-way of County State Aid Road No. 67 over the westerly 33 feet of said Northeast Quarter of Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$).

and the same is hereby annexed to and included within the City of New York Mills as effectively as if it had originally been a part thereof.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Town Clerk of the Town of Newton, the County Auditor of the County of Otter Tail and the Secretary of State of the State of Minnesota.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and upon the filing of the certified copies as directed in Section 3.
