ORDINANCE NO. 45

AN ORFINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FREEBORN TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated September 4, 1979, requesting annexation of the territory hereinafter described was duly presented to the council on the 4th day of September, 1979; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the westerly boundary thereof;

The city council of the City of Freeborn, Minnesota ordains:

<u>Section 1</u>. The city council hereby determines (1) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

<u>Section 2</u>. <u>Territory Annexed</u>. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Block 50, Block 51, and South $\frac{1}{2}$ of Main Street between the East side of Eleventh Street and the West side of Ninth Street and all of Tenth Street between the North side of Park Street and the South side of Main Street, together with all unvacated alleys, all according to the plat of Freeborn, Freeborn County, Minnesota on file and of record in the Office of the Freeborn County Recorder, said land containing 3.025 acres.

<u>Section 3</u>. <u>Filing</u>. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

<u>Section 4.</u> <u>Effective Date</u>. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section... 3, and approval of the ordinance by the Minnesota Municipal Board.
