ORDINANCE

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY OF BROWNSDALE, MINNESOTA, CURRENTLY ADJOINING SAID CITY OF BROWNSDALE.

WHEREAS, all of the owners of the hereinafter described property consisting of approximately 1.23 acres have petitioned the City of Brownsdale for annexation of said property; and

WHEREAS, copies of the petition have been filed with the Minnesota Municipal Board, the township of Red Rock and the County of Mower and no written objections to said annexation have been filed.

NOW THEREFORE, the Common Council of the City of Brownsdale do ordain:

Section 1. It is hereby found and determined that the property hereinafter described is now or about to become urban in character and it is in the best interests of the City to annex said land.

Section 2. The property hereinafter described is hereby annexed to the City of Brownsdale:

The West 180 feet of the following described land:
That part of Outlots 48 and 49, in Section 9,
Township 103, Range 17, described as follows:
Beginning at a point 62 rods 1 foot West of the
Northeast Corner of Block 3, Village of Brownsdale,
thence West 17 rods 15 1/2 feet to a point 80 rods
West of said Block 3, thence South 18 rods, thence
East 17 rods 15 1/2 feet to a point directly South of
the place of beginning, thence North 18 rods to the
place of beginning.

Section 3. The City Clerk shall immediately file said annexation Ordinance after publication with the Minnesota Municipal Board, the township of Red Rock and the County Auditor of Mower County and the Secretary of State of the State of Minnesota.

Adopted by the Common Council this 8 day of September, 1980.
