ORDINANCE NO. 155

Proposed Ordinance #2/80

BEING AN ORDINANCE RELATING TO THE ANNEXATION OF THE CITY OF WATERVILLE OF CERTAIN LANDS SITUATED IN RURAL WATERVILLE TOWNSHIP, LE SUEUR COUNTY, MINNESOTA.

The City of Waterville does ordain:

Section 1. That pursuant to the provisions of M.S.A. 414.033, Subd. 5 and upon a finding by the Common Council that such property is about to become urban in character the following described lands are hereby annexed by the City of Waterville and shall henceforth be included within and be a part of the corporate limits of the City of Waterville, Minnesota, to-wit:

That part of the Southwest Quarter of the Southeast Quarter (SW 1/4 of SE 1/4), Section Twenty-six (26), Township One Hundred Nine (109), Range Twenty-three (23), Le Sueur County, Minnesota, described as follows:

Beginning at the Northwest Corner of said Southwest Quarter of the Southeast Quarter (SW 1/4 of SE 1/4); thence on an assumed bearing of South along the west line of said Southwest Quarter of the Southeast Quarter (SW 1/4 of SE 1/4), a distance of 548.00 feet to the centerline of Trunk Highway No. 60; thence North 78 degrees, 30 minutes East along said centerline, a distance of 409.57 feet; thence North 70 degrees 01 minutes East along said centerline, a distance of 344.94 feet; thence on a bearing of North 0 degrees 55 minutes East, a distance of 336.80 feet to north line of said Southwest Quarter of the Southeast Quarter (SW 1/4 of SE 1/4); thence North 89 degrees 05 minutes West along said North line of the Southwest Quarter of the Southeast Quarter (SW 1/4 of SE 1/4), a distance of 731.00 feet to the point of beginning. This tract contains 7.63 acres of land, more or less, and is subject to any and all easements of record.

The parties of the first part reserve unto themselves for as long as either of them shall live an access easement for roadway purposes over the easterly two rods of the property herein conveyed.

Section 2. All Ordinances and portions of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 3. This Ordinance shall be in full force and shall take effect from and after its passage, publication and after filing copies

hereof with the Minnesota Municipal Board, the Le Sueur County Auditor, Secretary of State of the State of Minnesota, the Town Board for Water-ville Township and final approval by the Minnesota Municipal Board and after compliance with any and all other provisions of applicable law.




