ORDINANCE NO. 80-3

AN ORDINANCE EXTENDING THE CORPORATE  
LIMITS OF THE CITY OF LINDSTROM TO  
INCLUDE CERTAIN UNINCORPORATED UNPLATTED  
LAND NOT EXCEEDING 200 ACRES IN AREA  
ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated July 28, 1980, requesting annexation of the territory hereinafter described was duly presented to the council on the 28th day of July, 1980; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, all objections to the annexation have been waived by the town board of Chisago Lakes Town and no other municipalities abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the South and West boundaries thereof;

The council of the City of Lindstrom, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

The North 240 feet of the Northwest Quarter (NW $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Four (4), Township Thirty-three (33), Range Twenty (20), lying East of the centerline of C.S.A.H. 25, containing .7 acre more or less.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.


Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.
