ORDINANCE NO. 99

AN ORDINANCE ANNEXING TO THE CITY OF MABEL IN FILLMORE COUNTY, MINNESOTA, TERRITORY ABUTTING ON SAID CITY PURSUANT TO THE PROVISIONS OF SECTION 414.033, MINNESOTA GENERAL STATUTES, AS AMENDED

The City Council of the City of Mabel, Fillmore County, Minnesota, ordains as follows:

WHEREAS, Othilde Gunderson, Tony L. Gunderson, and Myrna E. Gunderson, being the sole owners of record of the real estate hereinafter described, duly petitioned the City Council of the City of Mabel to have said real estate annexed to and included within said City, and

WHEREAS, said real estate abuts on said City, is not included in any other municipality, is unplatted, and does not exceed 200 acres in area, and

WHEREAS, the annexation of said real estate hereinafter described to said City will be to the best interest of said City, of said real estate, and of the territory affected thereby, said real estate being of an urban character,
