ORDINANCE NO 180

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLAYTON, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, this territory abuts upon the corporate limits of the city at the eastern boundry thereof and is deemed to be urban or suburban in character; and

WHEREAS, this territory is owned in fee by the city;

THE CITY COUNCIL OF THE CITY OF SLAYTON, MINNESOTA DOES ORDAIN:

Section 1. Territory annexed. The corporate limits of the city of Slayton are hereby extended to include the platted and unplatted property described as follows now owned by the city:

Lot 37 of the recorded AUDITOR'S PLAT OF SAMPSON & FRENCH'S SUBDIVISION OF THE S. $\frac{1}{2}$ OF THE S.W. $\frac{1}{4}$ OF SECTION 10, AND PART OF LOT 1 OF THE S.E. $\frac{1}{4}$ OF THE S.E. $\frac{1}{2}$ OF SECTION 9, T. 106N., R. 41W., MURRAY COUNTY, MN., and the Northwest Quarter of Section 10, Township 106 North, Range 41 West, Murray County, Minnesota excepting therefrom the two following described parcels:

- 1.) Commencing at the north quarter corner of said section; thence West, assumed bearing, along the north line of said section, a distance of 550.00 feet to the Point of Beginning of the parcel to be excepted; thence South a distance of 250.00 feet; thence West, parallel with said north section line, a distance of 30.00 feet; thence South a distance of 315.70 feet; thence West, parallel with said north section line, a distance of 870.00 feet; thence Northwesterly to a point on said north section line which is West a distance of 1085.00 feet from the Point of Beginning; thence East, along said north section line, to the Point of Beginning.
- 2.) Beginning at a point on the west right-of-way line of U.S. Trunk Highway 59, a distance of 1153.05 feet south of the north line of said section; thence West, at right angles to said right-of-way line, a distance of 458.5 feet; thence South at right angles a distance of 190.00 feet; thence East at right angles a distance of 458.5 feet to said right-of-way line, thence North along said right-of-way line, a distance of 190.00 feet to the Point of Beginning.

said overall parcel contains 145.72 acres of land, more or less, and is part of said Northwest Quarter and said Auditor's Plat.

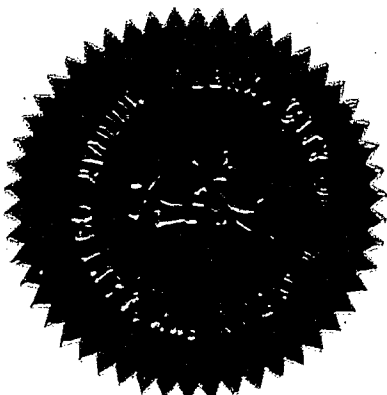
Section 2. Zoning District. The land hereby annexed to and include within the city is hereby designated as an Agricultural District A-G.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective date of annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3.

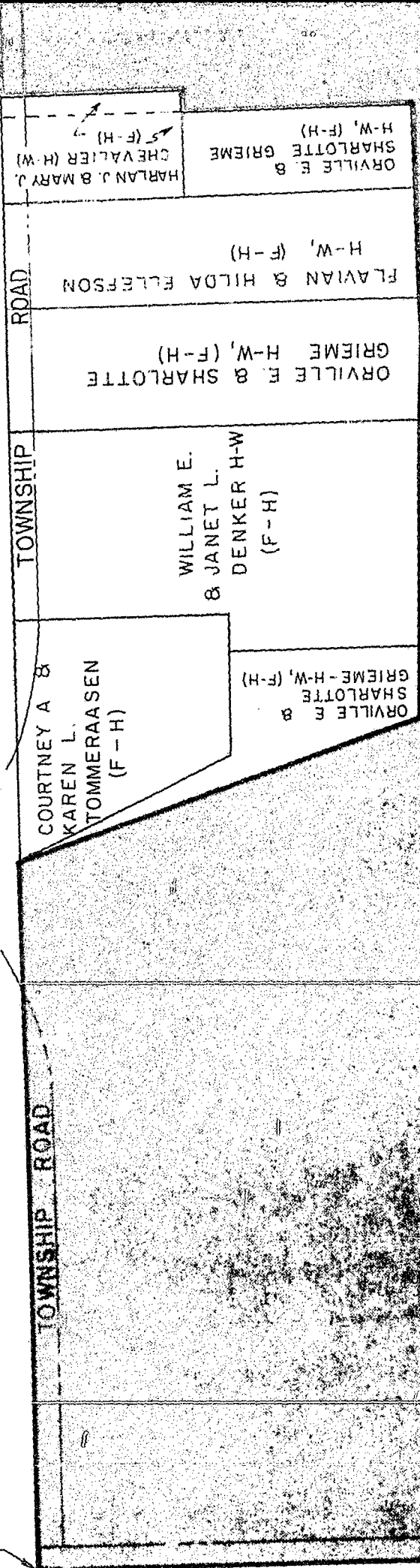

PROPOSED SLAYTON AN

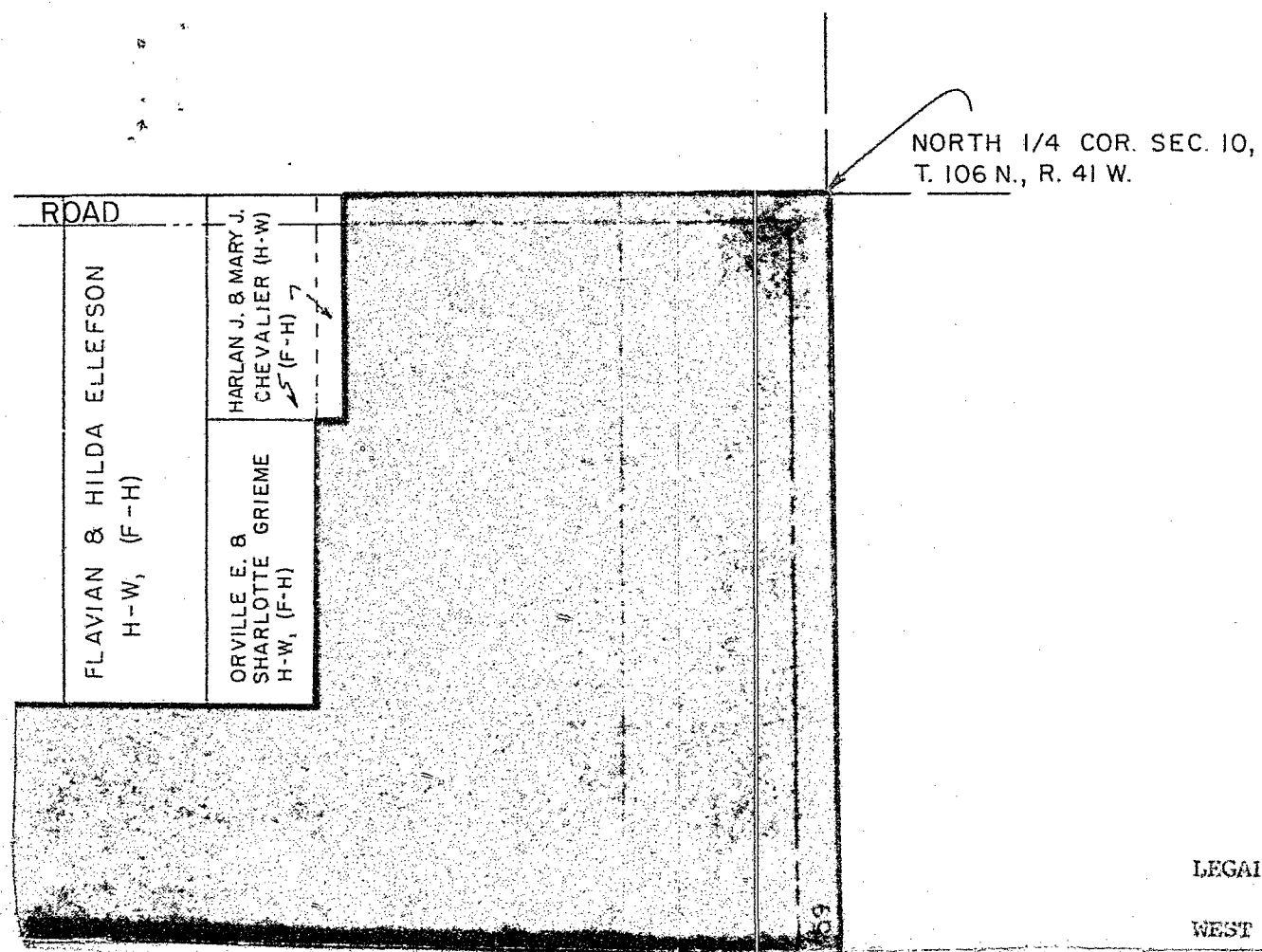
IN PART OF THE WEST HALF OF SECTION

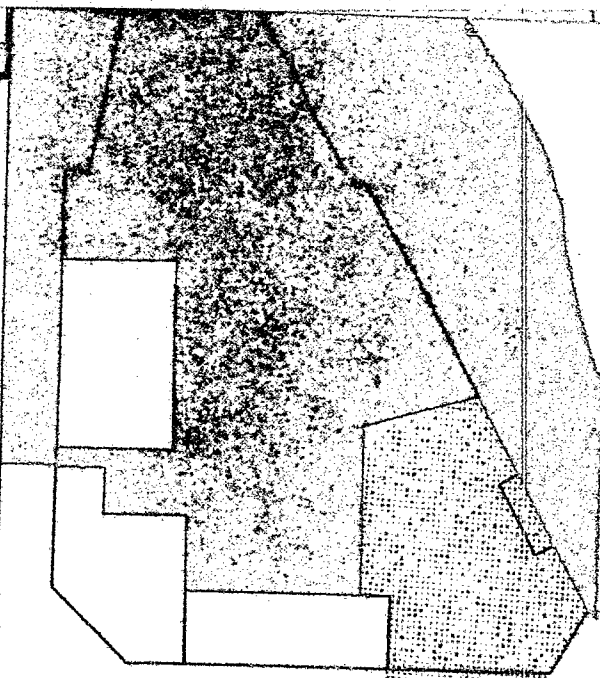

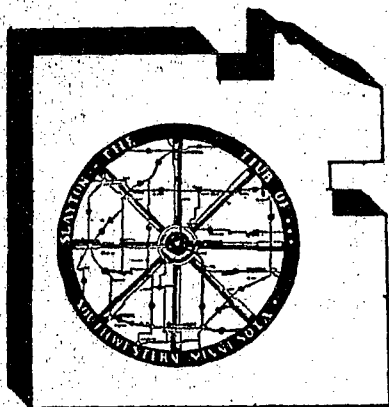
