## CITY OF WAYZATA HOME RULE CHARTER AMENDMENTS DECEMBER 2, 1980

Section 31. Contracts. In all cases of work to be done by contract, or for the purchase of property of any kind, when the amount involved is more than two theusand-five-hundred-dellars-(\$2,500) ten thousand dollars (\$10,000), unless the council by an emergency ordinance shall provide otherwise the city manager shall give not less than ten days public notice of the time and place of receiving bids therefor. The council may reject any or all bids. The council may regulate by ordinance the making of bids and the letting of contracts.

Section 44. Accounts and Reports. The city manager shall be the chief accounting officer of the city. The council may prescribe and enforce proper accounting methods, forms, blanks and other devices consistent with the law, this charter, and the ordinance passed under it. The manager shall submit to the council a menthly quarterly statement showing the amount of money in the custody of the city manager, the status of all funds, the amounts spent or chargeable against each of the budget allowances and the balances left in each, and such other information relative to the finances of the city as the council may require. The accounts of all city officers who receive or have custody of public funds shall be audited annually by a competent public accountant or by the state comptroller, and an annual statement showing the receipts and disbursements of the city shall be published.
