

ORDINANCE NO. 359

BEING AN ORDINANCE RELATING TO THE ANNEXATION TO THE CITY OF LE SUEUR OF CERTAIN LANDS SITUATED IN RURAL OTTAWA TOWNSHIP, LE SUEUR COUNTY, MINNESOTA.

The City of Le Sueur does ordain:


Section 1: That pursuant to the provisions of M.S.A. 414.033, Subd 5 and upon a finding by the Common Council that such property is about to become urban in character the following described lands are hereby annexed by the City of Le Sueur and shall henceforth be included within and be a part of the corporate limits of the City of Le Sueur, Minnesota, to-wit:

Commencing at the Northwest corner of the North One-Half of the Southwest Quarter of Section One (1), Township One Hundred Eleven (111) North, Range Twenty-six (26) West, Le Sueur County, Minnesota; thence proceeding Southerly along the West line thereof 200 feet to a point; thence proceeding Easterly parallel with the North line of said North One-Half of the Southwest Quarter 200 feet to a point; thence proceeding Northerly parallel to the West line of said North One-Half of the Southwest Quarter 200 feet more or less to a point on the North line of said North One-Half of the Southwest Quarter; thence proceeding Westerly along said North line 200 feet more or less to the point of beginning.


Section 2: All Ordinances and portions of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.


Section 3: This Ordinance shall be in full force and shall take effect from and after its passage, publication and after filing copies hereof with the Minnesota Municipal Board, the Le Sueur County Auditor, Secretary of State of the State of Minnesota, the Town Board for Ottawa Township and final approval by the Minnesota Municipal Board and after compliance with any and all other provisions of applicable law.


