

#### ORDINANCE NO 181

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLAYTON TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban or surburban in character;

THE CITY COUNCIL OF SLAYTON, MINNESOTA ORDAINS:

Section 1. Territory annexed. The corporate limits of the city of Slayton, Minnesota, are hereby extended to include the platted and unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:






