ORDINANCE NO. 124

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF FAIRMONT, MINNESOTA, AND PROVIDING FOR THE ZONING THEREOF

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA AS FOLLOWS:

Fairment

Section 1. That the property hereinafter described abutts upon the corporate limits of the City of Fairmont, Minnesota, and that notice of City of Fairmont's intent to annex was served upon the chairman of the Rolling Green Township Board, the affected property owners, the Martin County Board of Commissioners and Planning Commission, and the Minnesota Municipal Board, on the 8th day of July, 1980, that it will be to the best interest of the municipality and the territory; that said property is urban in character and subject to annexation pursuant to M.S.A. Sec. 414.033.

Section 2. That said property is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

A tract of land in the Northeast Quarter of the Southeast Quarter (NE¹/₄ SE¹/₄) of Section One (1), Township One Hundred Two (102) North, Range Thirty-one (31) West, Martin County, Minnesota, said tract being described as follows:

Commencing at the East Quarter (E_4^{L}) corner of said Section One (1); thence South 00 degrees 00 minutes 00 seconds West along the East line of said Section One (1) a distance of 367.48 feet to the point of beginning of the tract to be described; thence North 90 degrees 00 minutes 00 seconds West a distance of 317 feet; thence South 00 degrees 00 minutes 00 seconds West a distance of 163.15 feet; thence South 90 degrees 00 minutes 00 seconds East a distance of 317 feet to a point on said East line; thence North 00 degrees 00 minutes 00 seconds East along said East line a distance of 163.15 feet to the point of beginning, containing 1.187 acres, more or less, subject to easements now of record in said County and State.

Section 3. That said property is hereby made a part of the Single Family Residential District "R-1A" of the City's Zoning Districts, and that the City Code and zoning maps be and the same hereby are amended to include all of the above described property as part of the Single Family Residential District as provided by said code.

Section 4. That this Ordinance shall be in force and effect from and after its passage and publication, and the filing of certified copies with the Municipal Board, the Martin County Auditor, the Secretary of State, the Register of Deeds for Martin County, Minnesota, and the town clerk of the Township of Rolling Green, Martin County, Minnesota.
