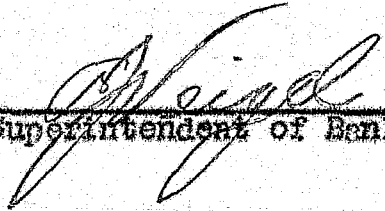
I, A.J. Veigel, Superintendent of Banks of
